## j) Business which has been proposed

The Union Secretary sought leave of Union Council to have the proposals considered without referral to Rules Committee, as the Committee's last meeting of the year was inquorate. Leave was granted by Union Council.

## Amendment of R67

Union Secretary Jover moved amendment to say "add the following" rather than "to the following"
Student Cara Rowe spoke to the purpose of the proposal, which was to reduce the amount of feeder tickets, which had seen significant proliferation at the last Union election, whilst still allowing individuals the opportunity to be legitimately nominated by more than one electoral group.

Cara Rowe also moved that the number of allowed electoral groups for positions listed in part (b) be raised from one to two. Cr Gutteridge spoke to this and said that raising the number of electoral groups allowed for a candidate in this section was in the view of Student Action a fair compromise.

Rowan Evans argued that (b) should be abolished entirely due to redundancy.

a) VICE-PRESIDENT (CAMPUS CULTURE) (VOTING); AND
b) SIX STUDENTS ELECTED BY THE CLUBS AND SOCIETIES GENERAL ASSEMBLY FROM STUDENTS WHO WERE PRESIDENT, SECRETARY OR TREASURER OF UQU-AFFILIFATED CLUBS OR SOCIETIES FOR THE TERM IMMEDIATELY PRECEDING THE GENERAL ASSEMBLY (VOTING)
7.2 ONLY ONE (1) ELIGIBLE NOMINEE TO THE CLUBS AND SOCIETIES COMMITTEE IS PERMITTED PER CLUB OR SOCIETY
7.3 NO STUDENT MAY SERVE ON THE CLUBS AND SOCIETIES COMMITTEE FOR MORE THAN TWO TERMS.
7.4 THE CLUBS AND SOCIETIES COMMITTEE IS DELEGATED GENERAL RESPONSIBILITY FOR OVERSEEING THE CLUBS AND SOCIETIES DEPARTMENT

### 7.5 WITHOUT LIMITING R7.2, THE CLUBS AND SOCIETIES COMMITTEE IS SPECIFICALLY RESPONSIBLE FOR:

(a) DEVELOPING STANDING RESOLUTIONS ON POLICY ON MATTERS AFFECTING AFFILIATED BODIES;
(b) ALLOCATING LOANS AND SUBISIDIES TO AFFILIATED BODIES;
(c) DIRECTING THE VICE-PRESIDENT (CAMPUS CULTURE) IN THE CONDUCT OF THEIR DUTIES WITH RESPECT TO AFFILIATED BODIES; AND
(d) DISCIPLINING AFFILIATED BODIES
