#### **President's Report**

The University has said via email that they intended to put up signs regarding wildlife but that this has not yet occurred. The President's meeting will be about broader wildlife safety issues, particularly during the Union complex redevelopment. Cr Adams noted that it appeared once again that the University's main priority was its image and advertising.

Jack Barton asked President Scott if she knew why the University had decided to close the veterinary clinic at Dayboro. President Scott stated that she did not know the reasons as she had not yet been able to discuss the issue with the University.

## **Uni Admin's Cancellation of Emails for Life**

Student Carl Nimmo spoke about his reliance on his UQ alumni email address, and that the decision to rescind the access to those emails on the part of the University was a very disruptive decision. Cr Adams stated that students had taken the University on their word, and that this will severely impact many people. Cr Adams further noted that the University's claims that they consulted were unsubstantiated, and that as the Union was the elected representative body of students the fact that they were not consulted should be of great concern.

Rowan Evans noted that a potential solution would be to never graduate from UQ.

#### **Dayboro Clinic**

Austin Smidt spoke against the closure of the Dayboro vet clinic, saying that it severely impacting hundreds of UQ students and staff, as well as members of the Dayboro community. Smidt called on the Union to support the motion and the petition.

Cr Walker waived his right to speak.

Chair Davis asked why Smidt was so interested in the issue. Smidt responded that this decision speaks to the broader problem of the University approaching decisions primarily from a commercial perspective rather than a learning perspective.

## **Online AGM's**

The Chair asked for clarification if the motion required referral to Rules Committee. Cr Creighton raised that a similar motion had been raised only two months before and had been rejected. The Chair asked for a point of order on whether or not it should be heard. Student Tristan Murdoch stated that it was fine for Council to reconsider the motion. Cara Rowe stated that now that AGM season was over it was appropriate for Council to revisit the issue.

The Chair decided to hear the motion.

Rowan Evans stated that he believed the motion was out of order as it should be referred to C&S Committee.

The Chair ruled the motion out of order.

Tristan Murdoch called for dissent in the chair.

Council voted for dissent in the chair.

Cara Rowe stated the importance for clubs to be able to hold their AGM's. She particularly noted the need for some clubs to hold general meetings over the summer break, and that forcing clubs to drag people back onto campus during this period would make it very difficult for clubs to reach quorum during this period.

Hughston Parle stated that it was standard for organisations to require in person AGM's and that many had done so. He also believed that this was an issue that should only be in the purview of the C&S Committee.

Cara Rowe noted that people travelled away from Brisbane during the summer break and that for some clubs it would be impossible to successfully hold a meeting.

Chair Davis stated that clubs should be responsible enough to not need to hold a general meeting over the summer break.
