

Appendix A

Regulations to be adopted as per the motion.

R150 Applicability of standing orders

- 150.1 Subject to the remainder of this Part, the standing orders will apply to General Meetings as if they were Union Bodies.
- 150.2 Despite 150.1, the following Standing Orders do not apply: S3, S4, S5, S7, S13, S16, S34.
- 150.3 For the purposes of questions to be put at the meeting as per C11.2, S21.2 does not apply.
- 150.4 For the purposes of S19, the meeting will be held in formal debate unless the meeting resolves otherwise. If the question is not affirmative in character, following the mover and seconder speaking, the next two speakers will speak from a contrary view, followed by speakers from alternate sides as per usual forms of debate. Example: If the mover and seconder of a question speak for a "no" vote, the following speakers to be called will be for a "yes" vote.
- 150.5 For the purposes of S33, if the meeting does not specify a time, date or place for the resumption of debate, the meeting must resume at a time, date and place specified by Union Council.
- 150.6 For the purposes of S36, the question may only be referred to a Referendum.
- 150.7 For the purposes of S14, unless the meeting resolves otherwise it is taken to appoint the Union Secretary as Minute Taker.

R152 Attendance

- 152.1 Only students may vote and speak at General Meetings.
- 152.2 Students wishing to attend the meeting must show a student card or otherwise verify that they are a student.
- 152.3 Non-students may attend in the capacity of observers but must be seated in a clearly demarcated area from the students.
- 152.4 Non-students may speak if a motion to that effect is passed by the meeting.

Appendix B

Current regulations, for the information of Councilors.

R150 Applicability of Standing Orders

- 150.1 Subject to the remainder of this Part, the standing orders will apply to General Meetings as if they were Union Bodies.
- 150.2 Despite 150.1, the following Standing Orders do not apply: S3, S4, S5, S7, S13, S16, S34.
- 150.3 For the purposes of S19, the meeting will be held in formal debate unless the meeting resolves otherwise.
- 150.4 For the purposes of S33, if the meeting does not specify a time, date or place for the resumption of debate, the meeting must resume at a time, date and place specified by Union Council.
- 150.5 For the purposes of S36, the question may only be referred to a Referendum.
- 150.6 For the purposes of S14, unless the meeting resolves otherwise it is taken to appoint the Union Secretary as Minute Taker.

R152 Attendance

- 152.1 Only students may attend General Meetings.
- 152.2 Students wishing to attend the meeting must show a student card or otherwise verify that they are a student.
