Regs Changes:

Banning electoral groups from using party names:

Secretary Cara Rowe spoke on the proposed motion explaining why it is a bad practice that needs to be stopped. She further mentioned that it is a deliberate ploy to confuse the students and a stance needs to be taken against it, to make elections more accessible.

The motion seconder Ryan Jover spoke on how the credibility of Union is affected by such practices and not agreeing with the motion would be doing a disservice to the union.

Elias Blanch spoke on how such practices are a barrier for the disabled students as it creates cognitive confusion.

Hughston Parle mentioned that the motion is broadly phrased and the unintended consequences of such regs changes can potentially affect parties. He further opined that it might be easier to make a list of parties and ban them rather than make it a blanket ban as it prohibits a lot of normal words from being used.

Secretary Cara Rowe clarified to the Council that the intended move is not have the power in the hands of student political representatives but rather leave it to the barristers in the election tribunal

Improving accessibility during elections

Incorporation Working Party:

Secretary Cara Rowe informed the members of the council on forming an incorporation working party that will meet every 2-3 weeks. She further mentioned that the T3 will be on the working party and invited other members of the Council to be part of the same.

To a query from the Chair on whether a decision has been made regarding the incorporation, Treasurer Radhika Peddibhotla clarified that working party will review the appropriate literature and then make a recommendation.

The Chair, Utkrist Paudyal, Ti parker, Matthew Burgin, Natasha Brettell, Marisha Robinson, Elise Northcote, Austin Smidt, Radhika Peddibhotla nominated themselves for the Incorporation Working Party.

I, Jack Walmsley move to expedite welfare bursaries for all UQ Res RAs Jack Walmsley spoke to the council on the recent events happening at UQ Res explaining how the dismissals of many RAs many of whom relied on the position for sustenance created a huge issue and why he is proposing this motion to expedite the grant of welfare bursaries for those students as the current waitlist for student welfare appointment at the union is almost 3-4 weeks.

President Emily Searle spoke to the Council explaining how the issue unfolded over time and agreed with the motion on Council endorsing the ways to help the UQ Res RAs at the earliest.

Elise Northcote mentioned it is heartening to see issues surrounding UQ Res are being highlighted at the Council and agreed that the Council should do everything possible to support them.

To queries from members of the Council, jack Walmsley clarified on the number of Ras, how the university is simply dragging it's feet in the name of various fact-finding meetings to discuss alleged incidents and violations including but only cited social media policy etc. He urged the Council members to find it important to ensure the affected students are taken care of.

Jake Coleman queried on what makes these student cases deserve special attention over those already in the waiting list and jack replied that he is speaking only on behalf of the affected UQ Res students and not trying to say who gets priority or why.

Treasurer Radhika Peddibhotla explained to the members of the Council how the SAS appointments are done, the element of triaging and how the severity or priority of each application received/processed is done on a case-by-case basis and that SAS staff will still use their discretion accordingly.

President Emily Searle spoke on the motion explaining various plausible options for Kev Carmody house to have representation in the Union, either bringing in a UQ Res officer or expand the definition of colleges to include Kev Carmody House etc.

To a query from Joshua Todd Cooper, President Emily Searle replied that the issue cannot be taken to the UQ Senate before this year's election and instead Council should consider having a Kev Carmody house officer for now.

Various Council members spoke on the issue, explaining the limitations involved in the solution proposed as well as the importance of addressing the concers of UQ Res Students.

The UQU Council condemns Semper Editor William Kugelman and UQU President Emily Searle for the publication of the recent edition of Semper

Natasha Brettell spoke on the proposed motion saying that the union should not advocate breaking the law or endorsing the usage of unparliamentary words.

Hughston parle spoke as the seconder of the motion on how the articles were not only in poor taste but also bring disrepute to the union and the impact it can have on those affected by the views expressed.

Dylan Thomas observed that Union and Semper are technically separate entities and in his opinion, Union isn't directly related to the articles published in Semper.

Barclay McGain mentioned that some of the articles published in the recent edition of semper are incitement for violence and breaking the law. He urged the council to take a stance on Semper Floreat having editorial integrity and condemn the recent articles and to ask for it to be retracted.

Louisa Mccarthy mentioned the hypocrisy of those who advocated against political censorship at the last council meeting only for now to oppose the publication of a student newspaper as it is against the opinions they hold.

Helen Craze spoke agreeing with the necessity aspect and free speech but still observed that the quote alluding to shooting was crossing the line.
