#### Reject the Higher Education Reform Bill

Cr De advised Union Council of the following:

- On 9 October 2020 the Federal Government approved Tehan's Higher Education Reform Bill which doubled fees for Humanities' courses and effectively amounts to funding cuts.
- This is an historic attack on higher education that will further deepen inequality in Universities.
- UQ Vice Chancellor Deborah Terry in her capacity as chair of Universities Australia has expressed positive general comments about the suite of reforms.
- The final discretion for the cost of degrees lies with University Senates. The UQ Union should call on the Senate to refuse to implement the fee increases when they are federally mandated on 1 January 2021.
- The Government mandates maximum fees, not minimum.
- It is well within the University's power not to accept fee increases. E.g. protests against a fee increase the Howard government tried to introduce years ago is a precedence for the University.
- The University administration has had an ambiguous stand on the issue.

Cr Heffernan added that the purpose of the motion was to recognise and criticise the University administration in passing fee increases.

Cr McGain raised that the bill is not about fee increases but to cut fees for students studying IT, Education, Clinical Psychology and Languages. Rather than an attack on higher education, the bill encourages students to consider employment outcomes upon graduation. The Current HECS debt is unsustainable and the current fee structure effectively subsidises study in the Arts and Humanities fields.

## **UQU PHOTOGRAPHY JOBS TO UQ STUDENTS**

Cr Plant received an anonymous request for UQ Union Photography to remain exclusive to students and alumni of UQ. He noted that event photography is funded by students' fees (SSAF) and is intended to enhance the experience and welfare of UQ students. The following was stated:

- Of the last 14 UQ Union events, 11 were assigned to external photographers (QUT students) even though UQ students indicated interest.
- The Union has previously dismissed photographers' concerns as a non-issue and these concerns have gone unheard for the last two years.

In discussion, the following was noted:

- UQ Union Photography offers an 8-hour credit to the Clubs and Societies community.
- A good supply of UQ photographers (students and alumni) is available.
- The use of external photography services financially impacts UQ students who rely on photography assignments.

- Delays noted in uploading event photos to the Union Facebook page.
- Photography of UQ Union events be handled by either a Council representative, the C&S Committee or UQ Union Photographers instead of the UQU Marketing and Events department.

Cr Trinh waived speaking rights.

Cr McGain stated that price and quality would have to be considered when engaging photographers.

#### **UQ Administration Attacks Staff Christmas Leave**

In early September, as part of her first attack on UQ staff in the name of "cost-saving," VC Deborah Terry announced that there would be changes to the typical leave arrangements for staff over the Christmas period. Up until this year, UQ has always had a mandated closure over Christmas, in which staff have been given 3 days of leave to account for the closure. This year, however, the University administration has announced that not only will those 3 days of additional leave be revoked, but that the Christmas closure will still be going ahead. As a result, the administration is claiming that it is a requirement for staff to use their own personal leave over those 3 days of closure. This disgraceful attack on the leave entitlements of hard-working staff is in fact a direct contravention of the UQ staff Enterprise Agreement, in which it is clearly stipulated that management cannot direct the taking of leave for any members of staff. In light of this, a number of activists in the NTEU have begun organising resistance to the UQ administration's new measures. It is essential that we, as students, stand with those staff who are leading this fightback and call out the UQ administration for their underhanded attack on the conditions of our educators.

Rizzalli advised that the University's mandate has seen the granting of 3 days' additional leave for staff during the Christmas period revoked and for University staff to use personal leave instead. The changes are in contravention of the enterprise agreement evidencing management running over existing, legally-established work rights; Rizzalli encouraged students to show solidarity with University staff and highlighted this as the first concrete attack on UQ staff in the name of COVID cost saving measures. If management is successful in implementing the changes, it will signal that they can continue with further, more farreaching attempts to cut pay and leave.

Cr Davis was against the motion stating that the use of personal leave during a Christmas closedown was normal practice in professional places.

#### **Natural Gas**

#### Cr Parker stated that:

- we are living in a climate catastrophe and it is shameful that both sides of the government continue to prop up the fossil fuel industry and to push development of the coal industry.
- University students have demonstrated that their number one concern is the environment and Union Council should therefore take a stand against the Federal Government's proposal for a 'gas led recovery'. The project will involve the expansion of fracking and natural gas is not clean but produces methane, which is more destructive than CO2 in the long term.
- in Queensland, the Labor government has announced that 18 new coal mines will be approved for central Queensland on top of the existing coal projects slated for the Galilee Basin.

Student, Ella Gutteridge, raised that it is an international disgrace that in a two-party system there is effectively no opposition on the issue and that Union Council should listen to students' demands for climate action.

#### UQ Union stands in solidarity with the Thailand protests for democracy

Student Matthew Mercer advised Union Council that the protests in Thailand are overwhelmingly student protests against an undemocratic government; a government that the Australian government has economic ties with and that the Union should therefore show solidarity with the protestors.

They described the situation:

"Over the last few days, tens of thousands have taken to the streets in Thailand in a determined fight to overthrow the monarchy in the name of democracy, also including demands for the removal of the nation's prime minister and amending the country's constitution. In a country where insulting the monarchy can be punishable with 15 years in prison, it is perhaps unsurprising that the struggle for democracy has been met with harsh state repression by the quasi-military government. More and more protesters, a large number of whom are young workers, university students, or high school students, have taken a heroic stand regardless. Many thousands were shocked and stirred into action by the Thai police's use of water cannons, using water laced with chemicals typically used to make teargas in order to harm and intimidate the protesters, and also laced with blue dye, so that police were able to identify protesters after the demonstrations had ended. Police have banned all political gatherings of 5 or more people, and so far arrested over 50 people, including some leaders of the movement, a targeted program of intimidation and repression. It's entirely possible that there could be a repeat of the student protests in 1976, in which the Thai military massacred at least 40 protesting students. The Australian government has a trade and economic relationship with the Thai government, so as Australian students in a neighbouring region, we have a responsibility to stand in solidarity with any of those who are struggling for democracy around the world, particularly when many of those struggling are students like us."

Cr De waived their speaking rights.

Cr McGain echoed the sentiment and expressed support for the motion calling for transparency.

#### Theft of data for electoral purposes

Cr Trinh explained that the purpose of the motion is to condemn Rebuild for the theft of student data during the election. They noted that Rebuild are yet to publicly distance themselves from the person responsible, giving the impression that the recently elected executive are complicit.

The Union President waived speaking rights.

Cr McGain queried whether the motion called for any concrete penalty to be imposed. In response, Cr Trinh noted that the issue has been referred to the relevant statutory authorities and it is up to the electoral tribunal to decide on an appropriate penalty.

Cr De stated that while they agreed that the action was a breach of student privacy, the motion is a cynical move designed as point scoring against political opponents. De said that the 90 minute (no campaigning) time out for Rebuild on the Friday of election week had been decided by the Returning Officer and that Council cannot determine an outcome.

UQ UNION COUNCIL ALSO EXPRESSES ITS DISAPPOINTMENT THAT REBUILD HAVE NOT PUBLICLY CONDEMNED THE ROGUE OPERATIVE ON ITS FACEBOOK PAGE, SHOWING THAT REBUILD ARE COMPLICIT IN STEALING STUDENT'S DATA.
- THAT UQ UNION COUNCIL EXPRESSES CONCERN THAT REBUILD HAVE CIRCUMVENTED ELECTORAL RULES AND REGULATIONS, IN A BID TO WIN THE EXECUTIVE, COUNCIL AND SEMPER FLOREAT BALLOTS DURING THIS YEAR'S UQU ELECTION.
- THAT UQ UNION COUNCIL EXPRESSES ITS OUTRAGE AT THE REBUILD ORGANISERS, FOR FAILING TO OUTRIGHTLY CONDEMN THOSE WHO OPERATE AS ROGUES. COUNCIL EXPRESSES ITS DISPPOINTMENT THAT REBUILD WOULD BE WILLING TO BREACH LAWS AND THE UNION REGULATIONS, AS A MEANS OF PERSUADING STUDENTS TO VOTE FOR THEM.

#### Workplace health and safety on University sites

Cr De waived speaking rights to Ella Gutteridge.

Ella Gutteridge advised Union Council that the motion relates to the recent death of a construction worker on campus at Curtin University when a roof collapsed on a construction site. The contractor was asked to speed up the process of installing glass prior to the incident, resulting in a pointless death linked to the University's desire to remain as profitable as possible.

Union Council was alerted to serious safety issues raised by the CFMEU on construction of the Liveris building. Given the recent death and serious injuries on construction at Curtin University, UQU should call on the administration to ensure safety standards are upheld and that UQU will support workplace safety stop works.

Cr Parker raised that council should stand in opposition to cutting corners when it comes to safety and all workers have the right to come home safe. The pressure that was exerted on construction workers by the Curtin University administration is directly linked to the fatality.

Cr Davis raised that contractors are ultimately responsible for maintaining safety standards, not the client. In response, Cr De noted that universities are responsible for whom they contract and for the for-profit model of universities puts workers' lives at risk.

## Question C – Academic Advocacy Network (AAN) on the incoming fee increases

Cr Heffernan queried the VP Fennell's response to fee increases.

Cr Heffernan questioned whether VP Fennell believed that the AAN has been an effective strategy in fighting the higher education bill fee increases and whether lobbying as opposed to protests was the more effective response.

VP Fennell explained that bringing the student voice to faculty members is the aim of the AAN, that a protest is not going to change a Head of School's opinion and that the AAN is not the avenue to fight fee increases.

Cr Heffernan noted that the Vice President's response demonstrates that lobbying is an ineffective strategy.
