The Treasurer's Report was starred for discussion.

The Finance Manager noted that the consolidated profit and loss statement for the year to date shows a surplus of -\$73k, compared with the budget of -\$5k. The largest impacting factor in Student Services for May was an overspend on student promotions, including the Queer Collaborations conference and Pride Ball. However, the Union received an extra income of around for indigenous events which compensates partially for the overspend. It was noted that the Business Trading arm has performed below budget as an aggressive budget had been set for the Food Services Department. They had been asked to achieve around 7% more revenue for 2018 but this has been impacted by an overall decline across campus in foot traffic as fewer students come to campus. It was noted that a particular focus will be put on wages for casual staff in the coming weeks. The Finance Manager and Operations Manager are currently working on a productivity tool that will aid supervisors in rostering staff to meet demand.

Councillor Hart queried by how much the union were out of pocket from the queer events. The Finance Manager explained that they will be able to provide a more accurate figure once all ingoings and outgoings are complete.

# j) Question Time

Union Environment Officer, Samuel Pulsford, asked for an update on the progress made with the UATSIS affiliation process.

#### Asylum for Biloela Family

Councillor Duncan Hart spoke in support of the motion. He raised that many organisations have come out in support of the family, who have been in Australia since 2000 and are valued members of their community. He explained that Peter Dutton has the discretionary power to grant the family asylum and suggested it would be a humanitarian gesture for the Union to support this motion.

Union Environment Officer, Samuel Pulsford, questioned why the application for asylum had been rejected. In response, it was explained that the Department of Home Affairs have not granted the family asylum as the Australia government does not consider the Sri Lankan Tamil community to meet the protection obligations of Australia. It was noted, however, this has been challenged by the UN and multiple people in the Tamil community have faced persecution and forced disappearances.

Officer Pulsford asked for clarification on the Councillor's definition of persecution.

In response, Councillor Hart explained that the Sri Lankan Tamil's are an ethnic minority that lost a civil war and the land of the Tamil people has endured extensive military occupation. The Tamil liberation struggle has led to enforced disappearances and executions.

The seconder of the motion, Councillor Adelaide Power, noted that the local economy relies upon the labour of those working at the meatworks and the community continue to hold vigils for the family.

The Environment Officer stated that he believed there was a lack of clarity and a precedent should be set that motions are well researched before they are brought to Union Council.

Councillor Ethan Van Roo spoke against the motion. He raised that Union Council's role is to represent students, as has been raised in previous meetings, and Council should not be considered with lobbying for social justice issues unless they directly impact on UQ students. Councillor Hart responded that this is a very limited frame for the Union and he has always disagreed with this assertion.

Student, Gavin Wilson, queried whether the father had been an active member of the terrorist group in Sri Lanka [The Liberation Tigers of Tamil] and stated that any person who has been involved in an illegal civil war does not deserve to be a part of Australian society.

Councillor Hart reiterated that, as far as he is aware, the reason the application for asylum was rejected was solely due to the Tamil community not falling under the protection obligations of Australia.
